a) No carrier is liable for loss, damage or delay to any goods carried under the Bill of Lading unless the carrier has received notice of the origin, destination and date of shipment of the goods, and the approximate amount claimed in respect of such loss, damage or delay is shown in writing to the originating carrier or the destination carrier within 60 days after the delivery of the goods; or, in the case of failure to make delivery, within 90 days.

NOTICE: By the third statement of the claim form to be filed within 60 months from the date of shipment together with a copy of this paid freight bill or any other statement of the carrier or of the contract for services herein referred to shall be deemed to be an acceptance by the carrier of the Province of Ontario of the Bill of Lading as required to make a declaration of value on the face of the bill of lading signed at the point of origin in which the liability of the carrier for loss, damage or delay to goods shall not exceed the declared value, and in the absence of such declaration the liability for loss, damage or delay to the goods of the carrier shall be limited to the value of the goods at the time of the invoice or other charges if paid, or \$4,411 per kilogram (20.00 per pound) computed on the total weight of the shipment.

b) The liability of the carrier for any other loss including consequential and economic losses, however arising, whether by the carrier's negligence or otherwise, shall be limited to the sum of \$500.00.

c) These provisions shall inure to the benefit of any carrier, servant, agent or employee participating in connection with the transportation referred to in the bill of lading.
